WATER

New Items

- We continue to work with Bowen and McMahon on design and planning of the new water plant and water main project. This, along with finishing the wastewater project, is taking up a considerable amount of time.
 - The land acquisition for the new wells is still proceeding. McMahon is close to the 90% design mark for the water plant.
- 2. Water and sewer lines locates for construction has become a major job to perform. A water service was hit by the contractor and will be repaired by them. Another line was hit on Route 2, which will be repaired by the contractor.
- 3. Water usage has increased in the past month. We may have a leak and will continue to monitor this. A leak has not been found.

Old Items

1. GIS – Little has been added. We are compiling more data, including the backflow prevention devices to include in the database. Aaron Flowers will be spearheading the GIS program. We have contacted McMahon to have the new water and force main lines added. MCO is bringing in a summer student who will be entering shut offs.

WASTEWATER

New Items

1. The Correctional Center Lift Station waste compactor has been plugging considerably. This is due to non-flushable items such as pillow cases, socks, and wire being flushed in the system.

Old Items

- 1. There is still an issue with the mapping system at Fieldstone Subdivision. The sanitary sewer locations on the atlas were wrong on two streets. We found three manholes, which two are buried very deep, and there may be severe conflicts with fences in the rear lots. We will contact a contractor to assist with this. We had M.E. Simpson on site to assist in locating services and shut-off valves. We found nearly half of the valves which could not be found. We are trying to find a contractor who will bring the manhole lids to grade.
- We were involved with the sewer connection to the duplex built on Flynn Road across from the grocery store-No further progress has been made.
